3. After the stated number of products and services included in the packages is exhausted, as well as the use of other services, the fees specified in the relevant sections of this Price List are applicable.
4. The European Economic Area (EEA) comprises the Member States of the European Union plus Norway, Iceland and Liechtenstein.

Notes:

- 1.** *When executing a payment transaction in the EEA, the fees paid by the originator and the payee are shared (SHA) - each pays the fees due to their payment service provider.*
 - (a) Where payments are made in a currency other than the currency of an EEA State and the payment service user is not an individual, it is possible that the charges may be borne entirely by the originator (OUR) or entirely by the payee (BEN), subject to individual agreement with the banks serving them and subject to agreement between the banks.*
 - (b) When executing a payment transaction outside the EEA, fees shall be paid (OUR/SHA/BEN) as specified by the originator and in accordance with the terms of the relevant payment system.*
- 2.** *When executing a payment transaction with OUR charges, the originator shall also pay the charges of the foreign banks (Correspondent Banks and Beneficiary Bank).*
- 3.** *Cut-off time - payment orders for credit transfers accepted until:*
 - a) SEPA - 16:00 o'clock;*
 - b) SEPA Instant - 24/7/365 (subject to availability of the recipient's PSP)*
 - c) TARGET - 17:30 o'clock;*
 - d) SWIFT - 17:30 o'clock,**shall be executed on the same business day, and those accepted after this hour - on the next business day.*
- 4.** *Payment orders for intra-bank credit transfers accepted before 22:00 o'clock shall be executed on the same business day, and those accepted after this hour - on the next business day.*
